Supplier Sustainability Policy

1. Purpose and Commitment

2. Human and Labor Rights

2.1. Child Labour and Young Workers

- Suppliers must not employ children under the minimum legal working age.
- Special protections must be provided for young workers to ensure their health, safety, and education are not compromised by work.

2.2. Wages and Benefits

- Suppliers must provide fair wages and benefits that meet or exceed legal and industry standards.
- Compensation must reflect the value of the work performed and be paid regularly and on time.

2.3. Working Hours

- Suppliers must ensure that working hours comply with local laws, including provisions for overtime, rest periods, and paid leave.
- Workers must not be required to work excessive hours and must have access to adequate breaks and days off.

2.4. Modern Slavery

- Suppliers must ensure that slavery, servitude, forced labor, and human trafficking do not exist within their operations or supply chains.
- Suppliers should provide written agreements to workers outlining the terms of employment, free from coercion or threat.

2.5. Ethical Recruiting

- Migrant workers must have equal rights and fair treatment without risk of exploitation.



2.6. Freedom of Association and Collective Bargaining

• Suppliers must respect the rights of workers to freely associate, join unions, and engage in collective bargaining without retaliation or intimidation.

2.7. Non-discrimination and Harassment

- Suppliers must provide a workplace free from discrimination based on race, gender, age, religion, sexual orientation, disability, or any other status.
- Harassment, abuse, and violence of any form will not be tolerated.

2.8. Women's Rights

- Suppliers must uphold women's rights, ensuring equal treatment and opportunities for women in the workplace.
- Policies must be in place to prevent gender-based violence, harassment, and discrimination.

2.9. Diversity, Equity, and Inclusion

- Suppliers must promote diversity, equity, and inclusion in hiring, promotion, and treatment of employees.

2.12. Use of Private or Public Security Forces

 Suppliers must ensure that security forces (private or public) employed to protect assets and personnel act in accordance with human rights standards and local laws.



3. Health and Safety

3.1. Health and Safety

- Suppliers must provide safe and healthy working conditions for all employees, in compliance with local health and safety regulations.
- Adequate measures must be in place to prevent workplace injuries, illnesses, and accidents, including proper safety training and equipment.

4. Business Ethics

4.1. Anti-Corruption and Anti-Money Laundering

- Suppliers must have zero tolerance for corruption, bribery, and fraud in any form.
- All financial transactions must be transparent and compliant with anti-money laundering regulations.

4.2. Data Protection and Data Security

 Suppliers must ensure the protection of personal and business data, complying with data privacy laws and taking appropriate steps to secure sensitive information.

4.3. Financial Responsibility (Accurate Records)
